Covid-19 impact

Since the very beginning of restrictions being imposed ABTC has been engaged with Central Government on a range of topics from raising the plight of the self-employed with the Treasury to ensuring that the drafting of changing restrictions took into account the wel-



fare of animals and the continuing need for the services of trainers and behaviourists. Our established chain of communication to Defra meant that the interpretation of working restrictions could be published quickly and the politicians had the best advice from ground level.

Up to date and authoritative advice for owners and practitioners across England and the devolved administrations has been and continues to be available on the ABTC website.

ABTC on Social Media

The recruitment of additional trustees early last year turned out to be a very timely move. All have been very busy in the newly created range of sub-committees not least of which is the Social Media group.



Regular dissemination of information on studies being carried out, quality webinars, general news items and of course, Covid-19 updates has seen the ABTC audience grow at an astonishing rate. In April this year it stands at approaching 7,200 followers on Facebook.

Membership Categories (new fee structure for 2021)

There are a number of different categories of membership of the ABTC.

Practitioner Organisation

Practitioner organisations are those that directly represent practitioners of animal training and behaviour therapy. Membership fee £250 annually.

Advisory Organisation

Advisory organisations are those that are animal welfare related stakeholders but do not directly represent practitioners. Membership fee £200 annually.

Individual

Individuals can only be members by invitation of the ABTC and they must have a particular skill or specialist knowledge that will benefit the work of the Council.

Supporting Organisation

Supporting organisations are similar to Advisory organisations although they have a much reduced membership fee. They may take part in discussions and consultations but they do not have any voting rights. Membership fee £75 annually.

Applications are always welcome and the necessary forms can be found on the website

Individual practitioner registration fees (suspended last year) will be reinstated at £15.

Has anything good come out of the pandemic?

Quite rightly most of the news surrounding the Covid-19 emergency has focused on the devastating effect it has had on society and at the family and individual level. With well in excess of 125,000 lives lost in the UK we are only now beginning to understand the longer term consequences for many many more, not to mention the widespread damage to so many businesses and charities.

As a charity ABTC has weathered the storm and remains relatively unscathed by the impact of the pandemic thanks to prudent financial planning and the dedication of its trustees and members. Other animal welfare charities have been harder hit from a serious drop in fundraising activities compounded by a dramatic increase in need for their services. The pet buying boom that was reported last year is now beginning to provide a consequential increase in need for rehoming services, often down to behaviour problems. Poor socialisation and separation issues are emerging as the most common culprits and while there is no 'quick fix' they can usually both be successfully addressed with some good advice and a little dedication on the part of the owners.

Much has been learned in a very short space of time about how to operate under the strict social distancing and isolation rules that we have all experienced for more than a year now. From a management perspective ABTC has gone from meeting up twice a year to hardly a week going by without a sub-committee meeting or trustees' meeting to discuss pressing matters thanks to the new norm of video meetings.

Trainers and behaviourists have had to adapt too and while there is no better solution than being face to face often with several owners and their pets, technology has provided some solutions here as well. We have even had reports of some behaviourists successfully dealing with cases internationally thanks to safe remote practices.

Being forced to review how we all work has brought about some short term changes that we hope will be temporary but some changes have brought about greater efficiency that could well be permanent features going forward.
