# **Progress towards regulation**

Readers will be aware that ABTC has for some years been in discussion with the Royal College of Veterinary Surgeons (RCVS) about us becoming an Accredited organisation under the RCVS umbrella.

We have put in a considerable effort to provide the RCVS with our processes and procedures to show that ABTC is a well-regulated organisation and that individual members of Practitioner Organisations have proven their competence in their chosen role. As they have slowly become aware of the level of detail required to regulate our sector it might not now be possible until the proposed Veterinary Services Act (which has yet to be drafted) is agreed. We continue to work together and we are still making progress towards our mutual aim but realistically it is going to be some time before it comes to fruition.

The most recent communication from RCVS commends ABTC for continuing to work towards the shared goal of raising and assuring standards in this key part of the vet-led team.

We remain convinced that our model of regulation of all trainers and behaviourists is the only viable way forwards to progress the implementation of standards that the industry so desperately needs.

## **BVNA** and **ABTC** collaboration

The BVNA has collaborated with the ABTC, to develop a new Learning
Pathway in Behaviour, as part of its CPD offer to its members.
The ABTC is proud to have developed this excellent new on-line re-

source, alongside the BVNA, for veterinary nurses who have an interest in behaviour.

The potential impact of developing the understanding and awareness of veterinary nurses of evidence-based approaches to changing animal behaviour is enormous in terms of improved welfare.

Veterinary staff are an important source of information for clients, and potential clients, about animal training and behaviour and it is essential that the information provided should be humane and evidence-based approaches and techniques. Working with owners will help the veterinary team to provide a fear free practice for their patients.

This new learning Pathway introduces these concepts and is a stepping stone for nurses who may want to study further to become behaviour professionals, in particular Animal Behaviour Technicians within the suite of ABTC Practitioner roles.

The ABTC team worked effectively and collaboratively with BVNA to produce on-line webinars, activities, reading opportunities for this assessed course. We hope that this sort of approach can be replicated in the future to develop further CPD opportunities for BVNA members. The Learning Pathway in Behaviour is due to launch in June 2022 and already over 400 nurses have registered their interest.

ABTC Advocates launching later this year...



The Trustees are putting the final touches to a new initiative which aims to raise funds and awareness for the charity. This scheme will initially be available to veterinary practices only, and if that is a success will be opened to other supporters too.

# **Membership Categories**

There are a number of different categories of membership of the ABTC.

## **Practitioner Organisation**

Practitioner organisations are those that directly represent practitioners of animal training and behaviour therapy. Membership fee £250 annually.

### **Advisory Organisation**

Advisory organisations are those that are animal welfare related stakeholders but do not directly represent practitioners. Membership fee £200 annually.

#### Individual


Individuals can only be members by invitation of the ABTC and they must have a particular skill or specialist knowledge that will benefit the work of the Council.

## **Supporting Organisation**

Supporting organisations are similar to Advisory organisations although they have a much reduced membership fee. They may take part in discussions and consultations but they do not have any voting rights. Membership fee £75 annually.

Applications are always welcome and the necessary forms can be found on the website Individual practitioner registration fees are £15 annually.

He is also is a long term supporter of ABTC. His debut book is about how we can choose a better life for animals, from the chickens we eat to the pets we keep.
