Welcome to the 23rd edition of the ABTC Gazette!

This edition brings what is probably the most significant news to report since ABTC was formed 15 years ago (see the UKAS article below). The work putting together the infrastructure to support and create a formal profession out of the unorganised collection of organisations that have appeared over the last three decades continues but this achievement clearly signals real progress.

Apart from the work on UKAS accreditation the trustees are kept busy with a range of activities such as attending the regular round of conferences, training assessors, fundraising and much more, there is a constant stream of items requiring attention.



Significant milestone achieved

We have just had the news from UKAS that their review of the ABTC Assessing Organisations Certification Scheme is confirmed as compliant with the requirements of ISO/IEC 17067:2013.

This standard describes the fundamentals of certification and provides guidelines for understanding, developing, operating or maintaining certification schemes for products, processes and services.

UKAS is the National Accreditation Body for the United Kingdom. They are appointed by government, to assess and accredit organisations that provide services including certification, testing, inspection, calibration, validation and verification. ABTC is often asked why we want to achieve UKAS

accreditation and there are two reasons: Firstly it provides independent confirmation that our processes are efficient and valid, assessments are accurate and we are competent to deliver our service. Secondly it was recommended by Defra as UKAS accreditation is a prerequisite to government recognition.

Full accreditation requires further assessments by UKAS against ISO/IEC 17065 which ensures that certification bodies operate in a competent, consistent and impartial manner. The ABTC council voted overwhelmingly to continue towards full accreditation in October and the process should get under way before the end of the year.

One thing this whole process has brought into clear focus is that it is highly unlikely the level of quality management required by UKAS is going to be matched anywhere else in the animal behaviour and training sector.

The shock collar debate has reopened in Scotland and ABTC are involved along with other high profile animal welfare charities and stakeholders.

Banning shock collars was a manifesto pledge of the SNP at the last election but so far it has not progressed beyond a code of practice.

In March 2023 the Scottish Animal Welfare Commission published a report that recommended they should be banned and now there is to be another consultation on the subject.



The ABTC was at the BVNA Congress in October sponsoring the behaviour lectures and providing speakers. This event has become a regular feature each year and provides a valuable point of contact with RVNs all over the country.

Membership Categories

There are a number of different categories of membership of the ABTC.

Practitioner Organisation

Practitioner organisations are those that directly represent practitioners of animal training and behaviour therapy.

Advisory Organisation

Advisory organisations are those that are animal welfare related stakeholders but do not directly represent practitioners.

Individual

Individuals can only be members by invitation of the ABTC and they must have a particular skill or specialist knowledge that will benefit the work of the Council.

Supporting Organisation

Supporting organisations are similar to Advisory organisations although they have a much reduced membership fee. They may take part in discussions and consultations but they do not have any voting rights.
